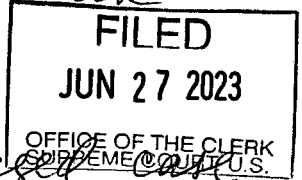

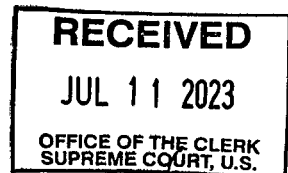

Grounds
