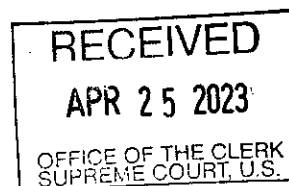



2. Due to the copies required, I had to wait until today Wednesday April 19th to purchase the copy cards and mailing supplies needed to prepare and return the corrected filing.


