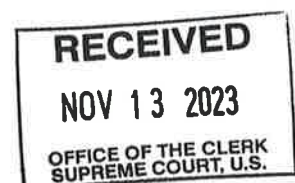

PETITIONER REQUEST PETITION FOR
REHEARING RULE 44 (1).

To: THE HONORABLE JUDGES: ROBERTS, THOMAS, ALITO, SOTOMAYOR, KAGAN, GORSUCH,
KAVANAUGH, BARRETT, AND JACKSON.

Plaintiff request a Petition for Rehearing of the judgment decision on October 2, 2023, because the decision of the Court on the merits was not decided. The United States Court of Appeals has decided an important question of Federal law that has not been decided, but should be settled by this Court. United States Supreme Court, rule 44 states. "The view of this Court as to the practice best adapted to the needs of the Federal courts and most responsive to the requirements of the Federal Constitution and statutes as well as to the decisions of this Court." (Bute v. Illinois (1948), 333 U.S. 640, 662 [68 S.Ct. 763, 775 [157, 92 L.Ed. 986].)

Representation is made of the intentions to file a petition for rehearing "presenting grounds which were not raised in the petition for certiorari, but which are available to them, and which are of a substantial nature."

(Docket Entry No. 2), Clark v. Romero, No. 10-55783 (9th Cir. Aug. 24, 2010), is

inadequate information to allege prior frivolous, malicious, or failure to state a claim upon which relief may be granted. See the exhibit, External Movements, on July 11, 2010, Plaintiff was paroled from TSP-facility to the County of Los Angeles, REG3 Compton #6.

Certiorari will not be usually granted in patent cases unless there is conflict in decision of court of appeals. Triplett v. Lowell (1936) 297 U.S. 638, 56 S.Ct. 645, 80 L.Ed 949, reh. (1936). Clark v. Mississippi, 143 S.Ct. 2406 (June 30, 2023). Writ of Certiorari is granted only in cases involving principles the settlement of which is of importance to public as distinguished from parties, and in cases where there is real and embarrassing conflict of opinion. National Labor Relations Board v. Pittsburgh S.S. Co. 304 U.S. 498, 71 S.Ct. 453.

The circuit court judges decided an unfair in forma pauperis proceeding, so Plaintiff's request that this Court grant to leave to proceed in forma pauperis, Pursuant to 28 U.S.C. Section 1915, subdivision (a) (1)(4). In the Interest of Justice Plaintiff request relief.
