1. I have been assigned to represent the defendant/petitioner Daniel Kim in all appellate/post-conviction proceedings. The Massachusetts Committee for Public Counsel Services, the state agency that oversees representation of indigent defendants issued counsel a notice of assignment of counsel (NAC) number, through electronic means, to keep track of the appointment, which is D22802743. C.P.C.S. made the appointment of appellate counsel on August 4, 2021.

2. As stated above, I was appointed through G.L. c 211D, § 5, which allows the appointment or assignment of

counsel to indigent defendants. *See* U.S. Const., Amends. 6<sup>th</sup>; 14<sup>th</sup>; *Gideon v. Wainwright*, 372 U.S. 335 (1963).

3. The Massachusetts Superior Court found the defendant indigent initially on October 17, 2014 [App. 20], and again on December 19, 2017. [App. 27].

4. The Commonwealth will not be prejudiced by the requested action.

5. The defendant is presently incarcerated.
