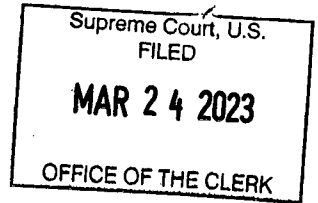

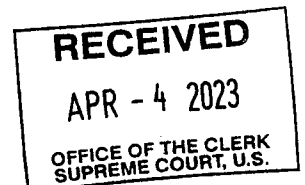

QUESTIONS PRESENTED

1. Did the State Court proceedings afford Due Process and Equal Protection of Laws under the Fifth Amendment and Fourteenth Amendment of the United States Supreme Court? By rejecting a Petition for Writ of Habeas Corpus where Petitioner is being illegally detained simply because claimant cannot afford to hire an attorney to represent the action filed in state court. In violation of this Court's ruling in *Gideon v. Wainwright*, 372 U.S. 335 (1963)

Case from **state courts**:

The opinion of the highest court dismissing review without ruling on merits of Petition for Writ of Habeas Corpus appears in Appendix – A To the present Writ dated 01-12-2023 case no.# SC22-1714

The Petitioner is illegally detained in violation of laws of the United States and is not entitled to relief under state law simply because he cannot afford an attorney.

CONSTITUTIONAL PROVISIONS INVOLVED

Fifth, sixth and fourteenth amendment of the United States Constitution and a violation of the Suspension Clause applicable to Writs of Habeas Corpus by state court simply because Petitioner cannot afford to hire an attorney to represent his claims before the state court.

STATEMENT OF THE CASE

Petitioner is illegally detained in violation of laws and Constitution of the United States because he cannot afford an attorney to raise his meritorious claims in state court in violation of his right to equal protection based on a state court Spencer Barr illegally suspending his right to file for Habeas Corpus relief unless filed by an attorney in good standing with the Florida Bar.

Which means a rich man who could file for relief because he can afford to hire a lawyer is entitled to relief and the poor man who cannot afford to hire an attorney is precluded from relief because he is poor. In clear violation of equal protection.

Petitioner further alleges that he never intended to abuse the judicial process as these motions were filed by law clerks in exchange for soups and chips and they are fleecing Petitioner while judicially barring his chances of getting relief based on my inexperience to reverse the Judgment and Sentence imposed. And the Court has never appointed counsel on Collateral Review on claims precluded from being raised in an appeal under state law.
