STATEMENT OF THE CASE

Petitioner was convicted on April 3, 2017, for sexual abuse of a minor. Petitioner's conviction was affirmed on direct appeal. Petitioner filed a petition for discretionary review, listing the following ground: Shouldn't basic due process allow a defendant to present to a jury that a child has similar, prior sexual experiences to show a child's basis to fabricate?

The Texas Court of Criminal Appeals refused Petitioner's PDR. Petitioner filed a pro se state habeas corpus application, and was denied without written order and court hearing.

Petitioner filed his federal petition for writ of habeas corpus, listing the following question: Whether due process allows a defendant to present to the jury that a child has similar, prior sexual experiences in order to show the child's basis to fabricate. The Court denied the claim based on Petitioner's failure to argue the ground. Petitioner also filed a COA with his habeas corpus, and was denied.

Petitioner then filed a COA in the Fifth Circuit Court of Appeals, and was denied for not arguing a denial of a constitutional right.

REASONS FOR GRANTING THE PETITION

The U.S. Constitution reads "We The People Of The United States". I was not included. My rights were violated in trial. Me and every american has the right to cross-examine a witness in trial. But that right was taken from me, and no court want's to hear about it. I brought my appeal to the federal court's but instead of the court appointing a lawyer, I was expected to write like one. Therefore, making an easy decision to denied my appeals, simply because I failed to show any errors. I am not a lawyer. How do the courts expect me to write like one?

I took my case to trial because I though there was going to be justice. I was wrong. Illegal's have more rights in this Country than I do. My trial involved illegal person's to testify against me, so they can benefit getting a U-Visa and avoid deportation into Mexico. Is that justice? I was born in the United States. I'm ashamed to be a U.S. citizen.

CONCLUSION
