



WRIT DENIED: Relator filed a writ application with this court seeking supervisory review of the trial court's May 3, 2021, denial of his application for post-conviction relief. In Relator's application for post-conviction relief, he alleged *Ramos v. Louisiana*, 590 U.S. ___, 140 S.Ct. 1390 (2020), applies retroactively to his non-unanimous jury conviction.

The United States Supreme Court recently held that *Ramos* and any other procedural rules will not apply retroactively on collateral review. *Edwards v. Vannoy*, ___ U.S. ___, 141 S.Ct. 1547 (2021). In *State v. Nelson*, 21-461 (La.App. 3 Cir. 11/10/21), ___ So.3d ___, this court adopted the Supreme Court's *Teague* analysis set forth in *Edwards* and held that *Ramos* does not apply retroactively on state collateral review. Therefore, the trial court did not err in denying Relator's application for post-conviction relief as it was untimely filed. Relator's judgment of conviction and sentence became final in 1985. *State v. Ledet*, 458 So.2d 1024 (La.App. 3 Cir. 1984), writ denied, 462 So.2d 1263 (La.1985); La.Code Crim.P. arts. 914, 922. Relator had until October 1, 1991, to file such an application. The current application was filed in the trial court in 2021, which is beyond the post-conviction relief time limitation.

Moreover, Relator has not proven a valid exception to the time limitation set forth in La.Code Crim.P. art. 930.8.

Accordingly, Relator's writ application is denied.
