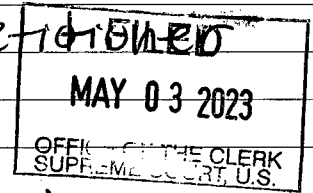

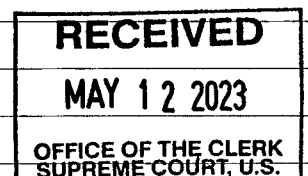


Motion For Leave to Proceed IN Forma Pauperis

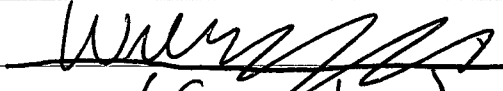
