The Petitioner has worked for weeks drafting his Petition for Writ of Mandamus and/or Writ of Prohibition with only one bad hand. Among other disabilities, the Petitioner suffers from Cognitive Decline, and he was mistaken in thinking the page limit was 50 pages.

The Petitioner is 74 and disabled. He lives alone in a trailer and has no help. He cannot walk. He has no balance. He falls a lot. Every disc in his neck and back are herniated or bulging or both. He has a Diastasis Recti abdominal injury. He needs hundreds of thousands of dollars in surgery, but he is in Chapter 13 Bankruptcy and can't afford any.

On 1/26/2022, the Petitioner had a fall and has lost use of his left hand. Cervical Fusion surgery is pending. The Petitioner is a two-finger typist with only one finger that shakes badly.

The Petitioner's teeth are rotting out of his head. He has had 15 extractions thus far. An extraction on 5/8/2023 was a nightmare of pain, and he is now on Oxycodone and Amoxicillin.

This case has a 12-year history, and the Petitioner spent weeks reducing the length of the Statement of Facts. It takes the Petitioner far longer than an able-bodied person to prepare filings.

His computer malfunctioned and is being shipped to Dell for repair.

The Petitioner asks that his 50-page Petition be accepted.
