LAST WILL AND TESTAMENT

OF

WILLIE BLEDSOE, SR.

I, WILLIE BLEDSOE, SR., a resident of San Joaquin County, California, declare that this is my Will.

FIRST: I revoke all Wills and Codicils that I previously made.

SECOND: I am married to Brenda Bledsoe, and all references in this Will to "my spouse" are to her. I was previously married to Vivian Ann Bledsoe, who is deceased. I have seven (7) children now living:

I have one deceased child, Anthony Bledsoe, who had no issue. The terms "my child" and "my children" as used in this Will shall include any other children hereafter born to or adopted by me.

THIRD: I confirm to my spouse her one-half interest in our community property and her one-half interest in our quasi-community property, if any.

FOURTH: I give, devise, and bequeath the residue of my

estate, which consists of all my separate property, my one-half interest in our community property, and my one-half interest in our quasi-community property.real and personal, wherever situated, to my children who survive me for thirty (30) days in equal shares. Should any child predecease me or fail to survive me for thirty (30) days, that predeceased child's share shall go to his or her issue who survive me for thirty (30) days in equal shares. Should that predeceased child have no issue or if none of his or her issue survive me for thirty (30) days, that predeceased child's share shall go to my remaining children in equal shares. As used in this paragraph, the term "quasi-community property" refers to the property in my estate that is described in Section 4803 of the Civil Code.

FIFTH: If any beneficiary under this Will or any person who, if I died intestate, would be entitled to share in my estate in any manner, directly or indirectly, contests or attacks this Will or any of its provisions, any share or interest in my estate given to that contesting beneficiary under this Will is revoked and shall be disposed of in the same manner provided herein as if that contesting beneficiary had predeceased me without issue.

SIXTH: I direct that all inheritance, estate, or other death taxes that may by reason of my death be attributable to my probate estate or any portion of it, including any property received by any person as a family allowance or homestead, shall be paid by my Executor out of the residue of my estate disposed of by this Will, without adjustment among the residuary beneficiaries, and shall not be charged against or collected from any beneficiary of my

probate estate.

SEVENTH: I hereby authorize and empower my Executor to collect, sell, convey, and convert into cash any and all of my estate at such time or times, and for such sum or sums, at either public auction or private sale, and with or without notice, as my Executor may determine, subject only to such confirmation of court as may be required by law.

I authorize my Executor to invest and reinvest any surplus monies in the Executor's hands in any kind of property, real, personal, or mixed, and every kind of investment, specifically including, but not limited to, interest bearing accounts, corporate obligations of every kind, preferred or common stocks, shares of investment trusts, investment companies, mutual funds, or common trust funds, including funds administered by the Executor, and mortgage participation that men of prudence, discretion, and intelligence acquire for their own account.

I further authorize my Executor either to continue the operation of any business belonging to my estate for such time and in such manner as my Executor may deem advisable and for the best interest of my estate, or to sell or liquidate the business at such time and on such terms as my Executor may deem advisable and for the best interest of my estate. Any such operation, sale, or liquidation by my Executor, in good faith, shall be at the risk of my estate and without liability on the part of my Executor for any resulting loss.

EIGHTH: In the event that any provision of this Will is, or is adjudged to be for any reason, unenforceable, the remainder

thereof, disregarding such provision, shall be carried into effect.

NINTH: I hereby nominate and appoint PEARLIE BLEDSOE Executor of this Will. If she fails to qualify or ceases to act as Executor, I appoint MICHELLE POWELL as alternate Executor. No person named in this Will as Executor shall be required to give bond.

TENTH: As used in this Will, the masculine, feminine, or neuter gender, and the singular or plural number, shall each be deemed to include the others whenever the context so indicates.

ELEVENTH: I have not entered into either a contract to make Wills or a contract not to revoke Wills.
