1. On August 18, 2021, the undersigned was appointed as stand-by counsel to Mr. Swinton for the instant appeal before the Second Circuit Court of Appeals.

2. *Pro se* defendant Robert Swinton, in a series of emails to the undersigned, set forth the contents of his Petition for Certiorari, Appendix, Word Count Certificate, and his Motion to Proceed Informa Pauperis.
