## JUDGMENT

Entered: May 2, 2022

Plaintiff-Appellant Lei Yin appeals the district court's order denying his motion for reconsideration in the underlying case. Defendant-Appellee Biogen, Inc., has moved for summary disposition. Our review is for an abuse of discretion. See Palmer v. Champion Mortg., 465 F.3d 24, 30 (1st Cir. 2006) ("[This court] will not overturn the district court's denial of a motion for reconsideration absent an abuse of discretion.").

After reviewing relevant portions of the record and the parties' submissions, we conclude that the appeal presents no "substantial question," and that summary affirmance is in order. 1st Cir. R. 27.0(c); see also Sparkle Hill, Inc. v. Interstate Mat Corp., 788 F.3d 25, 30 (1st Cir. 2015) (this court "do[es] not consider arguments for reversing a decision of a district court when the argument is not raised in a party's opening brief"); United States v. Zannino, 895 F.2d 1, 17 (1st Cir. 1990) ("[I]ssues adverted to in a perfunctory manner, unaccompanied by some effort at developed argumentation, are deemed waived."). We **GRANT** Biogen's motion and **AFFIRM**. All other pending motions, to the extent not mooted by the foregoing, are **DENIED**.

Affirmed. 1st Cir. R. 27.0(c).
