1. I am incarcerated at the Utah State Prison.

2. I receive a monthly stipend of \$40.00 for the work I perform at the prison.

3. I am not employed by the prisons Utah Correctional Industries, ("UCI").

4. I do not have any assets.

5. I use the stipend to purchase hygiene, writing supplies, legal supplies, and phone calls.

6. I do not expect any major changes to my monthly stipend/income during the next 12 months.

7. I cannot pay an attorney for services in connection to this case.

8. I am serving an aggregated 30 year sentence. I have been incarcerated since 2016 and have not been released since.
