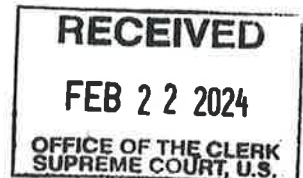

these substantial grounds were not previously
presented:

the effects of the states actions created a
burden which results in unequal access to the
court through an affinity-fraud against Amen
El's person's RACE & CULTURE which in turn

Here the State abuses it's Judicial powers

black men w/o due process of law. The sophisticated
apparatus to achieve this result is demonstrated by




