## APPLICATION FOR EXTENSION OF TIME TO FILE PETITION FOR WRIT OF CERTIORARI TO THE UNITED STATES COURT OF APPEALS FOR THE FIFTH CIRCUIT

Under Rules 13.1, 13.3 and 30.1 of the Rules of this Court, a petition for writ of certiorari was due to be filed on or before July 6, 2022. In accordance with Rule 13.5 is being filed 10 days in advance of the filing date for the petition for a writ of certiorari.

Petitioner James S. Harber, respectfully request a 60-day extension of time within which to file a petition for a writ of certiorari because of unforeseen circumstances including spending twenty days (from March 22 to April 12, 2022) at a Federal Transfer Center in Oklahoma. Then was relocated to the Coleman II facility in Coleman, Florida on April 12, 2022. There was no access to numbers for 3 days and nothing was noted on the Bureau Prisons Site for a slightly longer period of time so the attorney didn't have an address to send any mail. The denial of the Certificate of Appealability was not delivered to me until around April 29, 2022.

During this period of time the Coleman facility was placed on Red Alert for covid concerns and access to the law library which is located in the inside recreational area was denied along with other areas outside of the dorm. The restrictions were lifted on or around June 11, 2022 and although access to the inside recreational area is open now and research can be resumed since this is a pro se filing, the printer is not functional because it is out of toner.
