Our estimated production time for softcover books once we have received proof approval is about 10-15 business days. If you would like us to do the formatting for you the timeline will look like this:

- 1. Get an Order Started: You can either make an account online and place an order using the Get a Price Tool **OR** feel free to give me a call and I can do it for you to help you make a halfdown deposit. Once the deposit is made, you will be able to upload your files using your Account Portal or the Send Files tool.
- 2. Design: After deposit and files are received, our designers will review your materials and contact you about starting your design within a few days. Depending on your design level. you may receive a few page preview of the interior design and cover BEFORE the whole design is completed. The designer will talk to you about any changes you may have then finish the complete design.
