PER CURIAM:

Dora L. Adkins appeals the district court's order adopting the recommendation of the magistrate judge, denying her requests for leave to file an emergency complaint and for leave to proceed on that complaint in forma pauperis, and dismissing her case. We have reviewed the record and find no reversible error. Accordingly, we grant Adkins' motion to amend her informal brief and affirm for the reasons stated by the district court. Adkins v.
