To the Honorable Amy Coney Barrett, Justice of the Supreme Court of the United States and Circuit Justice for the Seventh Circuit:

Pursuant to Supreme Court Rule 13.5, Petitioner Elizabeth Richert respectfully requests an extension of time of 60 days to file her Petition for Writ of Certiorari in this Court up to and including August 18, 2023.

### **JUDGMENT FOR WHICH REVIEW IS SOUGHT**

The judgment for which review is sought was entered on February 24, 2023, in the United States Court of Appeals for the Seventh Circuit, Case No. 21-3203, on appeal from the United States District Court for the Northern District of Illinois, Eastern Division, (attached as Exhibit 1). On March 22, 2023, the Seventh Circuit Court of Appeals denied Petitioner's timely filed motion for rehearing en banc, (attached as Exhibit 2). This means a Petition is presently due on June 20, 2023. This application for an extension of time is filed more than ten days prior to that date.

### **JURISDICTION**

This case arises under the Fifth and Fourteenth Amendments to the United States Constitution. This court has jurisdiction under 28 U.S.C. § 1254(1).

### **REASONS FOR GRANTING REQUESTED EXTENSION OF TIME**

Petitioner has multiple, permanent, physical disabilities impairing her ability to sit and type for extended periods of time. Apart from Petitioner's permanent, physical disabilities, Petitioner is contending with multiple, significant

health issues. For the foregoing reasons, Petitioner requires additional time within which to file her Petition in this case.

No prejudice would arise from granting the extension. The judgment has issued, and no stay is in place.

### CONCLUSION

For the foregoing reasons, Petitioner respectfully requests this Court grant an extension of 60 days, up through and including August 18, 2023, within which Petitioner may file her Petition.
