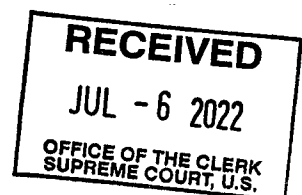

1. THIRD CIRCUIT ENTERED
A JUDGEMENT ON DECEMBER

26, 2021 CASE 21-1571. MR PAVULAK
FILED A PETITION FOR REHEARING
AND WAS DENIED APRIL 14, 2022.
UNLESS EXTENDED, THE TIME TO
FILE A PETITION FOR CERTIORARI
IS JULY 13, 2022.

2. IN AUGUST 2018 MR. PAVULAK
FILED A RULE 60 MOTION FOR
RELIEF FROM JUDGEMENT ON
ORDER OF PETITIONER PAVULAK
28 U.S.C. 2255 BASED ON
RULE 60(d)(3) FRAUD ON THE
COURT BY COURT OFFICER.

3. THE DELAWARE DISTRICT COURT DENIED THE RULE 60(d)(3) FRAUD AS RULING IT A SECOND OR SUCCESSIVE 2255 AND LACK OF JURISDICTION. A COA WAS DENIED AND A RECONSIDERATION ALSO DENIED FOR THE SAME REASON ON APRIL 14, 2022.

4. THIS CASE REPRESENTS AN IMPORTANT QUESTION ABOUT THE COURT'S RELIANCE ON A FALSE AFFIDAVIT FROM AN OFFICER OF THE

COURT THAT WAS RELIED ON
BY THE JUDGE TO PROCEDURALLY
BAR MR. PAVULAK'S AND PUBLIC'S

9. MR. PAVULAKI WAS DENIED HIS CONSTITUTIONAL RIGHT TO ATTEND HIS VOIR DIRE. HIS ABSENCE WAS OBJECTED TO JUST PRIOR TO VOIR DIRE AND OVER RULED BY THE JUDGE, STATING THAT DEFENDANTS ARE NOT ALLOWED TO ATTEND THEIR JURY SELECTION.
