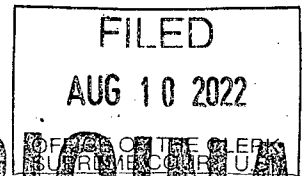

I, Gregory Ramos, being duly sworn, deposes and says:

1. I am the petitioner in the above mentioned matter.
2. I make this affidavit in support of an application for an extension of time to file a Writ of Certiorari.
3. There have been several developments that prevented petitioner from submitting a Writ of Certiorari within the 90 day time requirements.
4. The mail in this facility hadn't been received by Ramos until days after decision was made final.
5. I was under the impression that the lawyer involved with the direct appeal had volunteered to submit the Writ of Certiorari after conversations had.
6. Co-Vid 19 restrictions make it difficult to access law library with efficiency. *Bounds v. Smith*, 430 U.S. 817 (1977) (not in accordance with the holdings in *Bounds v. Smith*).

7. Based on the facts , I am requesting until October 17, 2022 to file a Writ of Certiorari . This time will be needed as it seems that the Clinton Correctional Facility is currently still running access to the law library on a Co-Vid 19 restricted procedure , and it is not unreasonable to assume that there will be limited access to the law library at Clinton Correctional Facility in the near future.

8. The access to counsel is limited to mail correspondence and One thirty minute call a month making it impossible for Petitioner to communicate his contentions clearly with counsel and get on the same page.

WHEREFORE , Petitioner respectfully request that an order be given granting an Extension of Time to file a Writ of Certiorari for a 60 day period and that the court grant such relief as it deem just and proper.
