MOTION FOR EXTENSION OF TIME

TO THE HONORABLE JUDGES OF THIS COURT:

COMES NOW, TIMOTHY MICHAEL UNZUETA ("Unzueta"), TDCJ#2209195, Petitioner Pro se and brings this Motion for Extension of Time to file a Writ of Certiorari ("WOC").

By the Rules and Order of this Court, Unzueta is required to file said WOC within 90 days of the denial of Unzueta's Writ of Habeas Corpus 11.07. Unzueta was "denied without written order" by the Texas Court of Criminal Appeals No. WR-93,893-01 on July 13,2022 making the due date October 11,2022.

Unzueta received the denial notification on 8/12/2022 almost a full month later (verifiable through the prison legal mail system). Unzueta a layman is experiencing extraordinary circumstances slowing needed research time. Unzueta is limited to a two (2) hour law library session five (5) days a week for research. Unzueta is limited to loaning and/or shepardizing a combined total of three (3) cases per day severly slowing much needed legal research for argument and understanding. Unzueta is also indigent and unable to retain a hired attorney.

This request is not designed to harass the Respondent, this Court, nor unnecessarily delay these proceedings, but to ensure Unzueta is fully and fairly able to address all issues properly. Furthermore, the Respondent is in no way prejudiced as Unzueta is incarcerated and operating under controlled and severe limitations. Unzueta is a layman and untrained in all aspects of legal research and writing.

Accordingly, Unzueta respectfully requests an extension of time of sixty (60) days up to and including December 11,2022 to file said WOC.
