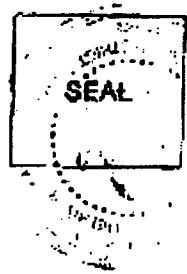

AFFIDAVIT of PROBABLE CAUSE

On November 4, 2021 at approximately 13:03 hours Upper Darby Police were dispatched to the Life Center of Eastern Delaware County, 6310 Market Street Upper Darby, PA 19082 for an indecent act that had just occurred. I, your affiant Officer Luke McCann #13 of the Upper Darby Police Department, responded. Upon arrival your affiant was directed to the victim, Teresa Unsel. Unsel informed your affiant that she was a volunteer at the Life Center and had been on location assisting as a lunch server. Unsel stated that she was working with a resident, Artis Carroll, and that it was her second time working with him.

Unsel informed your affiant that Carroll asked her to go to the back of the kitchen to "help" him with something. Upon reaching the back of the kitchen, Artis unzipped his pants and then exposed his erect penis. Unsel stated that she immediately ran out of the kitchen and informed other Life Center volunteers and administration of what had happened. At that time Unsel called 911 to report the incident.

Unsel completed a voluntary written statement detailing the above. Your affiant made contact with Carroll, who was asked what had occurred. Carroll informed your affiant that he had been working with Unsel and that he had asked for help with his "botched circumcision". Carroll was placed into custody at that time and transported to Upper Darby Police Headquarters for processing and housing pending arraignment.

Based on the information set forth above, which I believe to be true and correct, I ask that the above named defendant (Artis Carnel Carroll) be made to appear before the issuing authority to answer to the charges as set forth above in the attached criminal complaint.

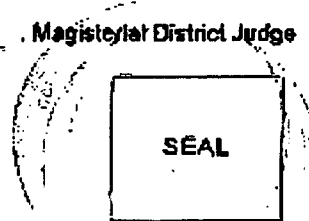


