4 In addition, Petitioner has numerous deadlines that  
5 are preexisting for cases involving Family-Child  
6 Custody @ the State level and also several  
7 cases requiring filings in the Federal jurisdiction  
8 - Federal Court of Claims and U.S. Court of Appeals  
9 for the Federal Circuit included.

11 obstructions and needless delays created by
