Because the Court of Criminal Appeals Dismissed, instead of denied my properly filed & Timely motions for En Banc Reconsiderations pursuant to TRAP 76(d), I am unaware whether this will be the date for the timelimit considerations of S.Ct.R. 13(3). Because of this, I am requesting an extension of time to file my Certificate of Certiorari.

The Writs for Habeas Corpus for causes: WR-86,912-09; WR-86,912-10; WR-86,912-11, were decided on: 07/27/22; 07/27/22; 08/10/22, respectively.

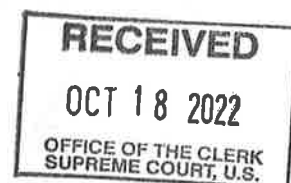
Without this extension I will not be able to obtain all of the required documents needed to support this petition, nor have it filed on time.
