 as I turn left, trying to roll the walker, with my hands cuffs behind
 my back, the walker hit me in my right leg scoring my leg, about
 125 six inch above my plate and 625 six screws in my born.
 The video camera tapes will show my walker falling over left,
 causing me to fall on the pavement hurting my left Arm Elbow Area
 scoring me, in more than one areas, fall on the pavement getting


