

REASON JUSTIFYING AN EXTENTION OF TIME

Applicant who is represnting herself without counsel respectfully requests a 30-day extension of time within which to file a petition for writ of certiorary seeking review of the decision of the Second Circuit in this case, up to and included December 4 2022.
