Motion For Postponement Of Time To File Petition For Writ Of Certiorari

Pursuant to USCS Supreme ct. R. 13.5, Petitioner Tony Deng respectfully requests this court to postpone or set a new due date for him to file a petition for certiorari after the final disposition of his motion to vacate filed on 11/8/2022 in the 9th circuit court of appeals. The current due date for filing a petition for Certiorari in this case is January 25, 2023. This request is timely and supported by the following reasons which establish great cause.

On 3/31/2022, the federal district court of Arizona denied Deng's Petition for a writ of habeas corpus and certificate of appealability (COA). Thereafter, Deng motioned the 9th circuit court of appeals for COA and the Motion was denied by a two-circuit-judge-panel for failing to meet COA standards on 9/30/2022.

Subsequently, Deny timely filed a motion for rehearing and his motion was also denied, on 10/27/2022, by a panel different than the one who denied the original motion for COA.

Under Supreme Ct. R. 13.3, the time to file petition for writ of Certiorari runs from the date of denial of motion for rehearing. However, after his motion for rehearing has been denied. Deng noticed that the court of appeals had abused its discretion, violating its own procedural rules, (9th cir. R. 27-10; and 9th cir. gen. Ord. 6.11) by assigning a different panel to rule on the motion for rehearing, Deng decided to file a timely motion, on 11/8/2022, pursuant to FRAP 27(b), requesting the court of appeals to vacate its order denying the motion for rehearing entered on 10/27/2022, and this motion to vacate is currently pending in the 9th circuit court of appeals.

Accordingly, Deng cannot filed his petition for certiorari until the final disposition of the motion to vacate because he cannot predict the outcome of that motion which might determine how some of the questions presented for certiorari will be framed.

Based on the reasons mentioned above, good cause is apparent. Deny respectfully requests this court to postpone or set a new due date for him to submit a petition for writ of Certiorari after the final disposition of his motion to vacate in the 9th Circuit Court of appeals.
