APPLICATION FOR AN EXTENSION OF TIME IN WHICH TO FILE A PETITION FOR A WRIT OF CERTIORARI TO THE ELEVENTH CIRCUIT COURT OF APPEALS

To the Honorable Clarence Thomas, Associate Justice of the United States and Circuit Justice for the Eleventh Circuit:

Pursuant to 28 U.S.C. § 2101(c) and Rules 13.5, 21, 22, 30.2, and 33.2 of this Court, Shannon Gladden ("Applicant") respectfully requests a 60-day extension of the time in which to file a petition for a writ of certiorari in this Court, to and including February 25, 2022. The Eleventh Circuit Court of Appeals denied rehearing on September 28, 2022, in *Shannon Gladden v. The*

Proctor & Gamble Co. No. 21-13535-BB. A copy of the Eleventh Circuit Court of Appeals' order denying rehearing is attached as Exhibit 1. A copy of the opinion from the Circuit Court is attached as Exhibit 2. This Court's jurisdiction would be invoked under 28 U.S.C. § 1254. Applicants' time to file a petition for a writ of certiorari in this Court will currently expire on December 27, 2022. This application is being filed more than 10 days before that date, and no prior application has been made in this case.

Undersigned counsel is working diligently, but respectfully submits that the additional time requested is necessary to complete preparation of a petition for a writ of certiorari. Undersigned counsel represents Applicant on a private retained but partially contingent basis. Undersigned counsel has represented Applicant since replacing prior counsel in the district court. Undersigned counsel is a solo practitioner and has supported the case in part by way of his other trial and appellate cases, from which he has not been relieved at any stage of the proceedings for the case.

Substantial work remains to present the Petition for Certiorari in a manner befitting the Supreme Court of the United States, to wit to complete research on the authorities supporting this Court's review, and to prepare the petition and appendix for filing. The undersigned counsel of record has also faced numerous overlapping deadlines in other matters, including a briefing deadline in the Eleventh Circuit Court of Appeals on December 19, 2022.

The normal time period has also encompassed part of the holiday season, which is also a factor here.

Wherefore, Applicant respectfully requests that an order be entered extending her time to file a petition for writ of certiorari up to and including February 25, 2022.
