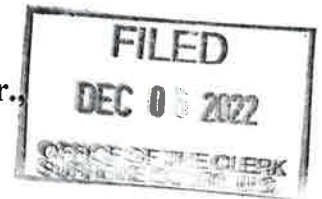

APPLICATION FOR AN EXTENSION OF TIME

Pursuant to Rule 13.5 of the Rules of this Court, Applicant John L. Dickerson, Jr., hereby requests a 60-day extension of time within which to file a petition for a writ of certiorari up to and including Thursday, December 22, 2022.

JUDGMENT FOR WHICH REVIEW IS SOUGHT

The judgment for which review is sought is *Arkansas v John L. Dickerson, Jr.* The Supreme Court of the State of Arkansas denied Applicant's motion for rehearing or modification on September 22, 2022 (attached as Exhibit 2).

JURISDICTION

This Court will have jurisdiction over any timely filed petition for certiorari in this case pursuant to 28 U.S.C. § 1254(1). Under Rules 13.1, 13.3, and 30.1 of the Rules of this Court, a petition for a writ of certiorari was due to be filed on or before July 30, 2018. In accordance with Rule 13.5, this application is being filed more than 10 days in advance of the filing date for the petition for a writ of certiorari.

REASONS JUSTIFYING AN EXTENSION OF TIME

Applicant respectfully requests a 60-day extension of time within which to file a petition for a writ of certiorari seeking review of the decision of the Supreme Court of the State of Arkansas in this case, up to and including December 22, 2022.

1. Applicant has requested that the Tulsa County Law Library of Tulsa Oklahoma Supreme Court Practicum assist in the preparation of his petition. An extension of time will permit the applicant the time necessary to complete a cogent and well-researched petition.

2. Counsel would not usually ask for a 60-day extension request, but does so in order to allow the applicant adequate time to research and complete.

3. The extension of time is very necessary. A 60-day extension for the Applicant would allow him the sufficient time for research and drafting efforts.

CONCLUSION

For the foregoing reasons, Applicant respectfully requests that this Court grant an extension of 60 days, up to and including December 22, 2022, within which to file a petition for a writ of certiorari in this case.
