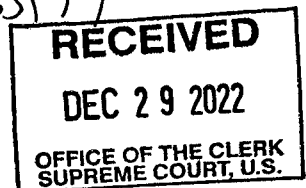

To The Honorable John G. Roberts, Jr., Chief Justice of The United States Supreme Court and Circuit Justice to The Fourth Circuit.

i. Pro Se Petitioner, Marco Laurati, pursuant to Rule 13(5), Rules of The Supreme Court, respectfully seeks a sixty (60) day extension of time within which to file his petition for writ of certiorari in This Court. The jurisdiction of This Court is invoked under 28 U.S.C. § 1257. This application is submitted more than ten (10) days prior to the scheduled filing date for the petition. The pertinent dates are:

a. October 18, 2022: issuance of written opinion of United States Court of Appeals for The 11<sup>th</sup> Circuit, See United States v. Laurati, case no. 18-10508, 20-12102 (11<sup>th</sup> Cir. Oct. 18, 2022) (affirming sentence and conviction). The opinion is attached as Exhibit A.

b. October 28, 2022: The 11<sup>th</sup> Circuit Court of Appeals granted an extension of time until December 8, 2022 in which to request a rehearing. That extension of time is attached as Exhibit B.

c. January 6, 2023: Deadline for seeking extension of time within which to file a petition for writ of certiorari in The United States Supreme Court.

d. January 16, 2022: Expiration of time for filing a petition for writ of certiorari in The United States Supreme Court.

2. This is a complex fraud case in which Petitioner was convicted to a 15 year sentence. See United States v. Laureti, case no. 18-10508 (11<sup>th</sup> Cir. Oct. 18, 2022) (affirming conviction and 15 year sentence). Petitioner's efforts to obtain post-conviction relief have been unsuccessful.

3. Petitioner is indigent. See United States v. Laureti, case no. 16-CR-60340 (Bloom) (CONN) at Docket Entry no. 166 (S.D. Fla. Apr. 4, 2018).

4. Petitioner is currently incarcerated at Miami Federal Prison Camp where operations have been materially altered by COVID-19 and, now, Miami Federal Prison Camp is on lockdown for inmates having been diagnosed with Chicken or Monkey Pox.

5. That lockdown, by extension, denies Petitioner access to the law library, typewriters, Trulinks emails, Trulinks phones, and photocopy machines; a situation that hinders Petitioner's ability to work on his petition.

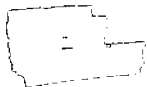
6. Petitioner appears pro se, seeks this Court to construe his pleadings liberally in accord with Haines v. Kerner, 404 U.S. 519 (1972).

7. Petitioner has never drafted a writ of certiorari and requires the extension of time not only due to the prison lockdown, however, to review the issues he intends to present as well as familiarize himself with this Honorable Court's rules; Petitioner needs access to the law library to work on this petition.

8. Petitioner has not contacted counsel for the United States of America for his position on this extension of time, however, because Petitioner has no way of communicating with anyone due to the lockdown.

For the foregoing reasons the petitioner, who is indigent and incarcerated in a prison with materially altered operations due to COVID-19 and Chikungunya / Monkey Pox, respectfully prays this Court grant an extension of time of sixty (60) days to and including March 17, 2023 within which to file his petition for writ of certiorari.
