- 4. The Appellant believes he needs an additional 60 days to provide this court with a presentable brief that complies with Federal Rules.
- 5. The Appellant also wishes to apprise the court that the Appellate court filings at the United States Circuit Court of Appeals for the District of Columbia Circuit has the only copies that the Appellant had in his possession since he was also on Lockdown status before and was unable to make photocopies of his briefs and appendixes, which he requires to draft and perfect his brief to present before this court.
- 6. Because the Appellant wishes to comply with the court's instructions pursuant to the federal rules, he files the present motion requesting an extension to comply with the court rules in his presentation to the court and simply representation to the
