MOTION FOR EXTENSION OF TIME

MAY IT PLEASE THE COURT:

I FILED A WITI OF CERTIORARI INTO THE LOUISIANA SUPREME COURT ON JULY 29, 2022 WHEREIN I CHALLENGED THE TRIAL COURT'S DENIAL THAT THE STATE OF LOUISIANA BREACHED THE PLEA AGREEMENT IN THE CASE BEARING DOCKET NUMBER 22C0022, IN DIVISION "B" OF THE TWENTY-SECOND JUDICIAL DISTRICT COURT; THE JUDGMENT ACCEPTING THE GUILTY PLEA IS AN ABSOLUTE NULLITY BECAUSE THE TRIAL JUDGE DEROGATED FROM THE STATE SEX OFFENDER REGISTRATION LAWS; AND THE CONTRACT PLEA AGREEMENT IS ABSOLUTELY NULL BECAUSE IT CONTAINS ILLEGAL TERMS; AND A COURT OFFICIAL DESTROYED THE BOYKIN TRANSCRIPT TO PREVENT ME FROM PROVING THE TERMS OF THE PLEA BARGAIN (AND TO PREVENT ME FROM PROVING THAT I REPRESENTED MYSELF DURING THE PLEA). DUE TO THE DESTRUCTION, I MOVED FOR THE SPOILATION OF RECORDS DOCTRINE TO APPLY.

The Louisiana Supreme Court denied the writ on October 18, 2022. I received the denial on October 26, 2022.

I received the 28 U.S.C. § 1257(a) application from this court on November 22, 2022.

I am in the Ellyn Hunt Correctional Center (EHCC). EHCC is NOT making getting my legal work done easy. I have had to file a ~~petition~~ for a temporary restraining order / preliminary injunction (TRO/PI) into the U.S. District Court for the Middle District of Louisiana concerning, inter alia, access to the law library. The docket number to that action is 22-CV-00864-BAT-SDJ.

Initially, I lost the TRO/PI but on 12/13/2022, the court granted the TRO/PI in part.


I am doing the best I can in my situation. I'm also having problems getting copies. At times, the prison does not copy all of my evidence. Some documents were not copied and did not come back to me.


