To the Honorable Brett Kavanaugh, Circuit Justice for the United States Court of Appeals for the Sixth Circuit:

- 1. For the specific reasons set forth below, Petitioner Kristofer Garrett respectfully requests, under Supreme Court Rules 13.5, 22, and 30.3, a sixty-day extension of time to file his petition for a writ of certiorari seeking review of *State of Ohio v. Kristofer Garrett*, 2022-Ohio-4218.
- 2. An Ohio jury convicted Kristofer Garrett of aggravated murder and recommended a death sentence as punishment. The trial court accepted that recommendation and the state court affirmed Mr. Garrett's conviction and death sentence on direct appeal. A copy of the opinion is attached.
- 3. On December 23, 2022, the court denied Mr. Garrett's Motion for Reconsideration. A copy of the order is attached.
- 4. Mr. Garrett seeks for this Court to review the Ohio Supreme Court's opinion of November 30, 2022. Jurisdiction in this Court is appropriate under 28 U.S.C. § 1257(a).
- 5. Good cause exists to justify Mr. Garrett's requested extension. Lead counsel represents other capital petitioners in various stages of state and federal litigation and requires additional time to draft a petition for a writ of certiorari. Lead counsel has briefing due in an *Atkins* case on March 31, 2023, and an appellate brief due in Ohio's Eighth District Court of Appeals on March 27, 2023. Co-counsel has a full caseload of capital and non-capital cases, at both the appellate and trial level.

Petitioner Garrett's counsel thus require an extension of time to adequately prepare his petition for a writ of certiorari.

Therefore, Petitioner Kristofer Garrett respectfully requests that an order be entered extending his time to file a petition for a writ of certiorari for sixty days, from March 23, 2023, until May 23, 2023.
