JUDGMENT FOR WHICH REVIEW IS SOUGHT

The judgment for which review is sought is Aymara Sorhegui v. Park East Home Owners Association Inc, 3D-21-1787(Oct 19, 2022 rehearing denied January 5th 2023) (attached as Composite Exhibit 1). On January 5th 2023, the District Court of Appeal of the State of Florida denied a timely motion for rehearing en banc (Composite Exhibit 1). This means a Petition is presently due on April 4th 2023.
