I declare under penalty of perjury under the laws of the United States that on April 26, at sentencing, the trial court suspended imposition of sentence for one year and imposed one week of imprisonment (community service) and \$220 in fines, plus a stayed \$150 additional fine that will become due if "probation" is revoked. I agreed to these "probation conditions" primarily in order to avoid mootness; the trial court will retain limited jurisdiction over me until probation expires or is revoked or terminated early. For one year, I will remain in jeopardy of suffering the punishments of imprisonment (up to 6 months) and/or fines (up to \$1000).

I further declare that my *Pen. C. 1272 (2)* right to release on own recognizance or bail pending appeal did not come up during the sentencing hearing because, during the hearing, my attorney lied to me, falsely stating that she had included a *1272* motion in the sentencing brief that she had filed. On information and belief, the judge could hear me clearly repeatedly asking my attorney, "What about *1272*? What about *1272*? Did you include *1272* in your filing?"
