

**PETITIONER'S MOTION TO DIRECT AN OUT OF TIME PETITION FOR A  
WRIT OF CERTIORARI**

(With especial appeal to the Honorable Neil Gorsuch, Associate Justice of the Supreme Court of the United States and Circuit Justice for the Tenth Circuit concerning United States Supreme Court Rule 13.5.)

Petitioner, Philip A. Bralich, Ph.D., respectfully makes Motion to this Court and especially to the Honorable Justice Neil Gorsuch, Circuit Justice for the 10<sup>th</sup> Circuit, for an order to Direct an Out of Time Petition for Writ of Certiorari. This Court has jurisdiction under 28 U.S.C. §1257. In support of this Application, Dr. Bralich states as follows:

Dr. Bralich is the Pro Se Appellant in *Bralich v. Gayner, et al* Case No. 0:2021cv01416 (See Exhibit) in the United States Court of Appeals for the Tenth Circuit wherein the Court of Appeals affirmed the Judgment of the lower court, the United States District Court for the District of Colorado, in the case of the same name, Case No. 1:20-CV-03800-RMR-STV.

1. Bralich's case raises important questions regarding constitutional issues, novel legal issues, conflicts between the States, and clearly established federal law. Specifically, a) four Constitutional issues arising from *Twombly-Iqbal* dismissals, b) *Pseudo-Sua Sponte* Dismissals and disagreements among the states concerning them, c) the novel and as at yet undecided issue of the growing problem of Workplace and Academic Mobbing and Bullying which might be called, "Equal Opportunity Bigotry," and d) an unaddressed problem concerning the abuse of Pro

Se litigants through Rule 16 status conferences held even before a Responsive Pleading has been filed.

2. Dr. Bralich now seeks a Writ of Certiorari for the United States Court of Appeals for the 10<sup>th</sup> Circuit with respect to the three-judge decision in that Circuit. This Court's jurisdiction to grant the same arises pursuant to 28 U.S. C. § 1254 (1).

3. According to Supreme Court Rule 13.3, a petition for writ of certiorari to was due on or before December 26, 2021 (where a 90 day deadline is approved for Pro Se Petitioners). See Supreme Court Rule 13.3 ("the time to file the petition for a writ of certiorari runs from the date of the denial of rehearing or, if rehearing is granted, the subsequent entry of judgment"). However, serious health issues prevented the Petitioner from completing the Petition before the deadline. Therefore, the Petitioner seeks an Order to Direct and Out of Time Petition. See Supreme Court Rule 13.5 ("[A] Justice may extend the time to file a petition for writ of certiorari for a period not exceeding 60 days").

4. This Motion is submitted in accordance with Supreme Court Rule 13.5. but as an "Out of Time" Petition. Further, the requested extension is made in good faith and not for the purposes of delay. Indeed, the requested extension is made because of the vital importance associated with the issues at hand – the right to equal access to the courts and to a fair trial, even for the Pro Se.. Thus, it is

necessary that Dr. Bralich be granted additional time to prepare his petition with the care demanded of such cases.

5. Illness, specifically, a heart condition requiring two surgical interventions with first the placement of an emergency temporary pacemaker and then a second surgery to implant a permanent pacemaker, and then a third hospitalization of yet another 6 days due to an accumulation of fluid on the lungs due to a mitral valve impairment and the concomitant debilitation of a few weeks before and after these incidents due to the newly discovered heart conditions and their remediation has precluded Dr. Bralich from being able to direct adequate time and attention to the preparation of the petition for writ of certiorari in this matter. Therefore, in light of the time lost due to illness and the importance of the constitutional issues and novel legal issues that will be presented in this case, Dr. Bralich submits that a sixty (60) day extension is necessary and appropriate in order for Dr. Bralich to effectively prepare the petition for certiorari.

6. In addition, two recent Court decisions that may impact on this matter indicate the decisions of the 10<sup>th</sup> Circuit and the District of Colorado may not be consistent with other states and remain in doubt. Specifically, in the related matter of Bralich v. Bell, et al, 1:2022cv01896 (Exhibit "A"), where the same torts and crimes are alleged to have spread from the religious community described in Bralich v. Gayner, et al have spread into the local community remains undecided but under consideration by the Court, and in Bralich v Brown, et al, Hfx. 518063 (Exhibit "B"),

a related case in the Supreme Court of Nova Scotia, Canada, the same allegations of failure to state claim and failure to state a cause of action, the Court found in favor of the Defendant, the Current Petitioner. This decision has yet to be published, but the fact that the Defendant's two, follow on Motions, a Motion for Default Judgment against one of the Defendants and a Motion for Reverse Summary Judgment against the Defendants were then scheduled to be heard on June 8, 2023 clearly indicate the decision in favor of the Plaintiff on these matters. The Petitioner has added the exhibit for the Bralich v. Bell, et al decision to this motion, and he will submit the Bralich v. Brown decision when it becomes available. He has attached them to this Motion rather than to the Petition for Writ of Certiorari in order to meet the requirement of the U.S. Supreme Court Clerk that new orders be appended as well as to avoid illegitimately submitting a Petition that was not identical to that previously submitted to the Court but rejected by the Clerk. Finally, in yet another related matter, which is pending before the United States Court of Appeals for the 10<sup>th</sup> Circuit concerning the Bankruptcy Drala Mountain Center, Bralich v. Drala Mountain Center 1:2022cv01433 (Exhibit "C") in which evidence and further details of the frauds described in Bralich v. Gayner is yet to be determined. This is also appended to this Motion rather than to the Petition for Writ of Certiorari to preserve the integrity of the original submission.

As for the consideration of Canadian law by U.S. Courts, in an article discussing the consideration of foreign law and state laws banning it, Eugene Volokh



of the UCLA School of Law, in an article in the Oklahoma Law Review (Vol. 66, Number 2, 2014) titled, "Foreign Law in American Courts" states

many such state laws are likely to interfere with the perfectly proper consideration of, for instance, foreign family law, contract law, tort law, and law of judgments, in those narrow contexts in which American law has long dictated that foreign law be considered.

Wherefore, in the interest of justice and for good causes shown, Dr. Bralich respectfully requests that this Court Direct this Out of Time Petition for Writ of Certiorari for consideration for hearing.

Plaintiff Philip A. Bralich, Ph.D., resides in Boulder, Colorado. On July 29, 2022, he filed *pro se* a Complaint (ECF No. 1)<sup>1</sup> and an Application to Proceed in District Court Without Prepaying Fees or Costs (Long Form) (ECF No. 3). In response to the Court's Order to Show Cause (ECF No. 4), Plaintiff filed a Response to the Order to Show Cause (ECF No. 5) and another Application to Proceed in District Court Without Prepaying Fees or Costs (Long Form) (ECF No. 6).

Upon review of the Response to Show Cause, Plaintiff will be granted leave to

proceed *in forma pauperis* under 28 U.S.C. § 1915 solely based on inability to prepay fees or give security therefor.

Accordingly, it is

ORDERED that the Application to Proceed in District Court Without Prepaying Fees or Costs (Long Form) (ECF No. 6) is granted. It is

FURTHER ORDERED that the court review Plaintiff's pleading pursuant to 28 U.S.C. § 1915(e)(2)(B). It is

FURTHER ORDERED that the Clerk of Court shall not issue process at this time. It is

FURTHER ORDERED that the United States Marshals Service shall serve process on any remaining defendant(s) for whom personal service is required if the case is later drawn to a district judge or a magistrate judge under D.C.COLO.LCivR 8.1(c). It is

FURTHER ORDERED that the Application to Proceed in District Court Without Prepaying Fees or Costs (Long Form) (ECF No. 3) is denied as moot. It is

FURTHER ORDERED that the Order to Show Cause (ECF No. 4) is discharged.
