TO: Chief of Staff for Clarence Thomas, Associate Justice, and/or Chief of Staff for Neil M. Gorsuch, Associate Justice.

This court denied review of this case on October 7, 2024, and stated no reason for doing so. Petitioner appears and moves this court for Reconsideration on the following grounds.

The subject matter of discharge in accord with the CISG Treaty (page 16 of original petition) is a constitutional issue of treaty law that (in this legal relation) operates by and through the Negotiable Instruments Act and the Bills of Exchange Act by and through Title 48 CFR Ch. 1, §53.228. In denying review/certiorari, the court has denied justice as a recognized future-labor-interest (FLI) depositor with the U.S. Treasury. To deny the existence of the deposit is to make ALL U.S. Citizens slaves to the banking community in violation of the 13<sup>th</sup> Amendment, involuntary servitude. Wars have started for reasons of less importance. This country is at the precipice of a polarized culture war that may go kinetic over economics. If this court does not deal with this FUNDAMENTAL issue, at the very least a statement of explanation, we could actually end up with a civil war for failure by the three branches of the PUBLIC TRUSTEES aka Government to acknowledge reality as "We The People" are the grantor/beneficiaries to the Grantor Trust Constitutions, Federal and State. Therein, the PUBLIC TRUSTEES work for the Grantor/Beneficiaries, not vice versa. Even communists understand that fundamental concept.

Whether the GSA Form bonds were drawn from an open, fully funded, Treasury Direct Account is a fact as proven by Sir Gary Lee Defluiter (Global



Gorsuch, Associate Justice) who appears to be more familiar in the premises. FRCP Rule 8(e) applies; (e) Construing Pleadings. Pleadings must be construed so as to do justice.
