**ORDER DISMISSING MOTION FOR

OF THE BIOLOGICAL MOTHER**

THIS MATTER came before the Court on the Motion for Reinstatement of Parental Rights of the Biological Mother ("Motion"), filed November 29, 2022, by the mother, Brittany Budlove, pro se. The Motion does not set forth grounds upon which the Court may consider reinstatement of the mother's parental rights, to include that the child is not at least 13 years of age, the child is in a prospective adoptive placement, and at least 36 months have not passed since the termination of parental rights.

¹ The Court notes that the mother's parental rights

were terminated on February 4, 2021, which was affirmed by the Second District Court of Appeal, on August 11, 2021, Case No.: 2D21-0357. The mother currently has a second appeal pending before the Second District Court of Appeal, Case No.: 2D22-0252.

WHEREFORE, IT IS HEREBY, ORDERED AND ADJUDGED that the Mother's Motion for Reinstatement of Parental Rights of the Biological Mother is DISMISSED.
