Dear Mr. Harris:

The federal government (defendants-appellees below) and plaintiffs-appellees East Bay Sanctuary Covenant, et al. (hereafter “East Bay Respondents”) are both respondents before this Court in the above-captioned case.

The petition for a writ of certiorari in this case was filed on June 26, 2024, and placed on the docket on June 28, 2024. On July 5, 2024, the federal government requested an extension of its response deadline from July 29 to August 28, 2024. The Court granted the request on July 8, extending the government’s deadline to August 28, 2024.

The East Bay Respondents now also respectfully request, under Rule 30.4, an extension of time from July 29 to and including August 28, 2024, in which to file their response to the petition for a writ of certiorari.

This extension is necessary in light of other federal court deadlines and pre-existing personal commitments.
