RE: Request for extension of time to file brief in opposition in *Trendily Furniture, LLC, v. Jason Scott Collection, Inc.*, No. 23-194

Dear Mr. Harris:

The Court docketed the petition for a writ of certiorari in the above-captioned case on August 31, 2023. Respondent Jason Scott Collection, Inc., waived response on October 3, 2023. On October 17, 2023, the Court called for a response, which is currently due November 16, 2023.

Pursuant to Supreme Court Rules 15.3 and 30.4, Respondent respectfully requests a 27-day, unopposed extension to December 13, 2023, to file its brief in opposition. Skadden was first retained to represent Respondent before this Court. The extension is necessary given the heavy press of other business. Between the call for a response and the requested deadline, counsel has needed and must continue to attend to briefing deadlines and argument preparation in several matters, including:

- October 18, 2023: filed jurisdictional reply in *Wallrich v. Samsung Electronics America, Inc.*, No. 23-2842 (7th Cir.)
- October 25, 2023: filed motion for stay pending appeal and motion to expedite appeal in *Samsung*, No. 23-2842 (7th Cir.);
- October 30, 2023: oral argument in *Culley v. Marshall*, No. 22-585 (U.S.);

- November 6, 2023: filed reply in support of motion for stay pending appeal and motion to expedite appeal in *Samsung*, No. 23-2842 (7th Cir.)
- November 7, 2023: oral argument in *Philadelphia Energy Solutions Refining & Marketing, LLC v. United States*, No. 22-1834 (Fed. Cir.);
- November 14, 2023: opening brief due in *Samsung*, No. 23-2842 (7th Cir.), on an expedited schedule;
- November 21, 2023: opening brief and joint appendix due in *United States v. Johnson*, No. 23-4255 (4th Cir.) (on three extensions);
- November 22, 2023: response brief due in *CSX Transportation, Inc. v. Norfolk Southern Railway Co.*, No. 23-1537 (4th Cir.) (on two extensions);
- November 27, 2023: cert petition due in *Kinzy v. United States*, No. 23A338 (U.S.) (on an extension; requesting an additional extension to December 22, 2023);
- November 27, 2023: cert petition due in *Norfolk Southern Railway Co. v. STB, et al.*, No. 23A226 (U.S.) (on two extensions);
- November 30, 2023: opening brief due in *Johnson v. Gentry*, No. 23-2124 (9th Cir.) (on an extension; requesting an additional extension to January 16, 2024).
- December 11, 2023: cert petition due in *Ravenell v. United States*, No. 23A212 (U.S.) (on two extensions); and
- December 12, 2023: oral argument in *TotalEnergies Renewables USA, LLC v. Trina Solar (U.S.), Inc.*, No. 22-16763 (9th Cir.).

Skadden has conferred with counsel for Petitioner, who states that Petitioner consents to the requested extension but no further extensions.
