## **Corporate Disclosure Statement**

Pursuant to Supreme Court Rule 29.6, Petitioner Marilyn Williams hereby certifies that Petitioner is a natural person and is not affiliated with any corporation or publicly held company.

To the Honorable Clarence Thomas, as Circuit Justice for the United States Court of Appeals for the Eleventh Circuit:

Pursuant to this Court's Rules 13.5, 22, 30.2, and 30.3, Petitioner Marilyn Williams respectfully requests that the time to file her Petition for Writ of Certiorari in this matter be extended for 60 days up to and including October 15, 2023. The Court of Appeals issued its opinion on November 7, 2022 and denied rehearing en banc on May 18, 2023. Absent an extension of time, the Petition for Writ of Certiorari would be due on August 16, 2023. Petitioner is filing this Application more than ten days before that date. *See* S. Ct R. 13.5. This Court would have jurisdiction over the judgment under 28 U.S.C. § 1254(1).

The time to file a petition for a writ of certiorari should be extended for 60 days for the following reasons:

First, the press of other matters will make preparation of the petition difficult absent an extension. In addition to this petition, counsel for Petitioner has been managing numerous recent and upcoming deadlines. Counsel is co-lead of one of the largest multidistrict litigations in the United States, *In re Acetaminophen - ASD-ADHD Prod. Liab. Litig.*, MDL No. 3043 (S.D.N.Y.); co-lead for the State of Texas (who is leading the litigation on behalf of 17 states) in *Texas v. Google*, No. 1:21-cv-06841 (S.D.N.Y.), and counsel of record in the remand to the Pennsylvania Supreme Court of the case *Mallory v. Norfolk Southern Ry.*, which was recently decided by this Court. Counsel is also presenting argument on dispositive motions in a hearing in a consolidated proceeding in Illinois state court on August 17, 2023, *Banna v. Walgreen*

Co., Case No. 2020-L-004916 (Cir. Ct. Cook Cty.), which is the day after the Petition would be due. In addition, counsel has a hearing in California state court on August 22, 2023, *In re Mead Johnson Prod. Cases*, No. JCCP 5257, CJC-23-005257 (Cal. Super Ct. S.F. Cty.). Additional time is necessary to prepare a thorough and comprehensive petition for this Court's review.

Second, no prejudice would arise from this short extension. If the petition were granted, the Court would hear oral argument in this case in the October 2023 Term regardless of whether an extension is allowed.

### **Conclusion**

For the foregoing reasons, Petitioner respectfully requests that the time for filing a petition for a writ of certiorari in this case be extended by 60 days to and including October 15, 2023.
