Cypress-Fairbanks Independent School District v. Jane Roe

Dear Mr. Harris,

I am counsel for the respondent in this case, Jane Roe. Petitioner filed its petition for writ of certiorari on September 25, 2023 and the petition was placed on the docket September 29, 2023. According to the online docket and pursuant to Rule 15.3 of the Rules of the Supreme Court of the United States the due date for a brief in opposition is October 30, 2023. Pursuant to Rule 30.4, respondent respectfully requests that the time for filing a brief in opposition be extended by 30 days, to and including November 29, 2023.

This is respondent's first request for an extension of time to file a brief in opposition. I was lead counsel for respondent Jane Roe in the trial court and on appeal to the Fifth Circuit. At the time the petition was filed on September 25, 2023, I was deeply involved in preparing for a trial in the United States District Court for the Western District of Texas, *Lozano v. Baylor University, et al*, No. 6:16-CV-00403-RP. Jury selection set for October 13, 2023 and testimony is scheduled to begin October 16, 2023. The trial of this case is expected to last two weeks.

Accordingly, respondent respectfully requests that the time for filing a brief in opposition to the petition for writ of certiorari be extended by 30 days, to and including November 29, 2023. Counsel for petitioner has informed me by email that they do not object to this request.
