**ORDER OF NONSUIT and RETURN OF  
WITHHELD COMPENSATION**

UPON CONSIDERATION OF the written motion to nonsuit and return withheld compensation, filed by the Commonwealth through her counsel, and the Respondent's letter to the Court noting his objection to those motions, the Court has reviewed the motions and issued a letter opinion on July 18, 2022.

The Court finds that there has been no prior nonsuit in this action, and no counterclaim, cross-claim or third-party claim has been filed. The Commonwealth is entitled to a nonsuit as a matter of right and it is therefore ORDERED that the Commonwealth's motion for nonsuit is GRANTED.

FURTHER, pursuant to Va. Code § 24.2-236, it is hereby ORDERED that the Commonwealth's motion to return the Respondent's withheld compensation to the Alleghany County Public Schools, or their successor in

interest, is GRANTED.
