**RE: REQUEST FOR EXTENSION OF TIME TO FILE OPPOSITION TO PETITION  
*Amazon.com, Inc., et al. v. Jennifer Miller, et al.*, S. Ct. No. 23-424**

Dear Mr. Harris:


I represent Plaintiffs-Respondents Jennifer Miller, *et al.*, in this case and am writing to request an extension of our deadline to submit an opposition to the petition for certiorari filed by Petitioners Amazon.com, Inc., and Amazon Logistics, Inc., which was docketed on October 23, 2023. Absent the requested extension, Respondents' opposition is due on November 22, 2023. Respondents seek a 30-day extension of that deadline, from November 22, 2023, to **Friday, December 22, 2023**.

This is our first request for an extension in this matter, for which there is ample good cause. Respondents' counsel has numerous other professional and personal commitments between now and November 22. These include substantive briefs in two other cases and multiple mediations, one of which requires Respondents' counsel to travel from Massachusetts to Tennessee. The requested extension is necessary to ensure that Respondents' counsel has an adequate opportunity to review and respond to the petition in light of those commitments.

Further, the requested extension would not meaningfully delay these proceedings. Petitioners have obtained a stay of the Ninth Circuit's mandate. Thus, a "speedy ruling" on the petition is not needed to protect Petitioners' rights in the underlying case, and there is no risk that they will be prejudiced in that regard by Respondents' proposed extension.

**Accordingly, Respondents request a 30-day extension from November 22, 2023, to and including December 22, 2023, to file their opposition to Petitioners' petition for certiorari.** Before writing this letter, I informed Petitioners' counsel of our intent to seek this extension. Petitioners' counsel has stated that Petitioners intend to oppose. Thank you for your attention to this matter.
