Re: Request for extension of time to file a brief in opposition to the Petition for a Writ of Certiorari in *Dora L. Bonner v. Triple S. Management Corporation, et al.*, No. 23-472

Dear Mr. Harris,

Our firm represents Respondents Triple-S Management Corporation and Triple-S Vida, Inc. Petitioner filed her Petition for a Writ of Certiorari in the above-entitled case on November 1, 2023. On November 3, 2023, the case was placed on the docket as No. 23-472. Absent an extension, pursuant to Rule 15(3) of the Rules of the Supreme Court of the United States, Respondents' brief in opposition to the petition is currently due December 4, 2023. Pursuant to Rule 30.4, Respondents respectfully request that the time for filing the brief in opposition be extended by thirty days, to and including January 3, 2024.

This request for an extension is Respondents' first. Respondents' counsel has had numerous professional and personal commitments prior to the current deadline, including travel abroad during and around the intervening Thanksgiving holiday week, that have made it impossible to complete a thorough review of the Petition and complete the preparation of a response. The requested extension is necessary to ensure that Respondents have an opportunity to review and fully address the arguments in the Petition for a Writ of Certiorari in light of counsel's other commitments. The extension will enable Respondents to adequately address why the Court should not grant certiorari in this case and, pursuant to Rule 15(2), to address the misstatements of fact and law in the Petition. Indeed, the requested extension will allow Respondents to better explain, in a way that is most helpful to the Court, that the Petition is a thinly veiled attempt to seek review of the underlying merits of the opinion issued by the First Circuit and that, contrary to what the Petitioner contends, no conflict between the Circuits exist related to the issues raised in the Petition. The extension of time is also necessary to account for the printing of the briefs. Respondents further note that the requested extension should not pose undue delay or burden,

especially considering that the Petitioner requested a forty-one day extension of time to file her Petition. Therefore, good cause exists for the requested extension.

Accordingly, Respondents respectfully request that the time for filing their brief in opposition to the Petition for a Writ of Certiorari be extended by thirty days, to and including January 3, 2024.
