## JUDGMENT

Entered: October 6, 2022

Pro se plaintiff-appellant Betsy Sachs appeals from the sua sponte dismissal of her civil action at the screening stage, 28 U.S.C. § 1915(e). Following a careful review of the limited arguments presented on appeal and relevant portions of the record, we affirm, substantially for the reasons set out by the district court. See Bradshaw v. Corr. Med. Servs., Inc., 6 F. App'x 45, 46 (1st Cir. 2001) (unpublished per curiam) (reviewing screening dismissals for failure to state a claim de novo). We add that, with her opening brief, Sachs has not sufficiently developed any claims of error focused on the district court's reasoning for dismissal, see United States v. Zannino, 895 F.2d 1, 17 (1st Cir. 1990) (arguments raised in only a perfunctory and undeveloped manner are deemed waived on appeal), and the arguments that are set out in the brief lack merit.

Affirmed. See 1st Cir. R. 27.0(c).
