

WRIT DENIED

Relator, Brandon Tate, seeks review of the district court's December 2, 2021 judgment denying his Motion to Challenge the Constitutionality of Petitioner's Guilty Plea. Relator asserts that he waived his right to a jury trial based on misrepresentations by the district court, prosecutors, and defense counsel. He argues that he was misled to believe that if he proceeded to trial, he could be found guilty by a non-unanimous jury verdict, in contravention of *Ramos v. Louisiana*, ___ U.S. ___, 140 S.Ct. 1390, 206 L.Ed.2d 583 (2020). However, that case was decided nine years after Relator's guilty plea. At the time Relator pled guilty, non-unanimous jury verdicts were held to be constitutional. Accordingly, Relator's writ application is denied.
