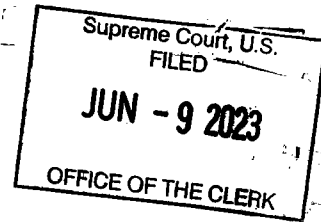

Here comes the petitioner, Jeremy Adams, respectfully requesting to proceed *in forma pauperis*. A Federal Public Defender was approved on 6/29/2022 under the Criminal Justice Act, 18 USC § 3006A, after the petitioner filed an affidavit in the original district court. Petitioner is currently in oppressive pretrial detention and has been so for more than two years, so his income has not improved.

The FPD became standby counsel after *Faretta* hearing on 9/9/2022. Petitioner proceeded *pro se* on appeal and had requested to proceed *in forma pauperis* but is unaware if there is a specific order granting leave explicitly but must have been granted implicitly since the appellant court issued an order on the merits with no fee due. Petitioner has been continuously detained since 5/18/2021. Supreme Court IFP form is attached.

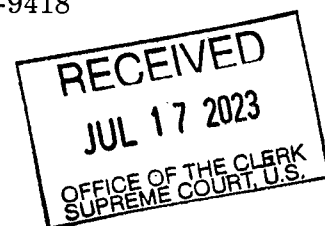


