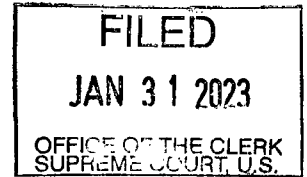

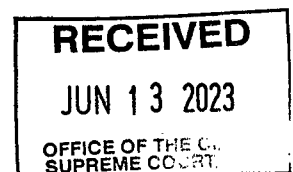
Dear Mr. Harris,

As Petitioner, This letter to you concerns what Petitioner avers is a breach of duty by your deputy Ms. Nesbitt, and also your breach of duty for allowing this to continue. Specificall, 28 USC §951, which states as follows:

§951. Oath of office of clerks and deputies

Each clerk of court and his deputies shall take the following oath or affirmation before cetering upon thier duties, "I, _____, having been appointed _____, do solemnly swear (or affirm) that I will truly and faithfully enter and record all orders, decrees, judgements and proceedings of such court, and will faithfully and impartially discharge all other duties of my office according to the best of my abilities and understanding. So help me God."

As Petitioner, regarding a motion for Mandamus No. 22M78, Petitioner has presented to this Court 3 (three) separate motions to proceed "in forma pauperis". Each time they have been returned because, "the notarized affidavit or declaration of indigency does not comply with Rule 39." As Petitioner pointed out to Ms. Nesbitt, Petitioner avers he has complied in substance with the rules regarding "In Forma Pauperis", however it has been insisted (demanded) that Petitioner's affidavit is not on the proper form. Petitioner stipulates Rule No. 1 states: "The Clerk receives documents for filing with the Court and has authority to reject any submitted filing that does not comply with these Rules."



Notwithstanding Rule 1, Petitioner avers 28 USC §1915(a) states in part the following:

(a)(1)"Subject to subsection (b), any court...a person who submits an affidavit that includes a statement of all assets such prisoner possesses that the person is unable to pay such fees..."

Petitioner directs your attention to page 3 of said affidavit, where Petitioner states: "I do not have access to any other legal tender or assets besides those in my prison Trust Fund Account." Given this clear statement, why then, does the Clerk of this Court continue to deprive Petitioner his "Due Process?" It has already been established the Deputy Clerk has not been transparent, as [s]he reluctantly admitted; "It was confirmed that your petition was retained by this office." Is it so unaccustomed that a regular citizen would call to account a public servant, let alone one in the position as Clerk of the Supreme Court??

Petitioner avers 28 USC §951 states in part; "...that I will truly and faithfully enter and record all...proceedings..."


Blacks Law Dictionary, Tenth Edition: Proceedings;

1. The regular and orderly progression of a lawsuit, including all acts and events between the time of commencement and the entry of judgment. 2. Any procedural means for seeking redress from a tribunal or agency. 3. An act or step that is part of a larger action. 4. The business conducted by a court or other official body; a hearing. 5. Bankruptcy. A particular dispute or matter arising within a pending case -- as opposed to the case as a whole.

Petitioner avers, the filing of motion to proceed "in forma pauperis", is in fact a proceeding before this court. Thus, a failure to 'enter' and 'record' said motion, is in fact, a failure of ones oath. While the Plaintiff does not wish to cause harm to anyone in this matter, it is strongly suggested the clerk reconsider their actions.

In summary, Petitioner avers the sworn statements submitted to this Court does in fact comply with both the letter and the substance of the law.


