


Dear Mr. Harris:

I am writing to notify the Court that this office will not be appearing for the New York City Campaign Finance Board in this case.

By order dated September 28, 2022, the U.S. District Court for the Eastern District of New York (Matsumoto, J.) *sua sponte* dismissed plaintiff's complaint on res judicata grounds, apparently before the defendant was served. The Court also certified that any appeal from the order would not be taken in good faith and therefore denied *in forma pauperis* status on appeal. The U.S. Court of Appeals for the Second Circuit affirmed on April 4, 2023.

This office did not appear on behalf of the New York City Campaign Finance Board in the court below. *See* Non-Appearance Letter, *Herschaft v. N.Y.C. Campaign Finance Board*, No. 22-2822, Dkt. No. 20 (2d Cir. Nov. 15, 2022). Therefore, this office does not intend to appear before this Court, or to file a response to the petition for a writ of certiorari, as indicated on the annexed Waiver form.
